



PCHS speakers have finished the last two weeks by successfully defending their first place ranking in both conference and district competition.

Traveling to Sutherland on March 5, varsity members competed in two rounds of preliminaries, with the top four advancing to finals.

The PCHS team totaled 224 points, with Maxwell coming in second with 186, and Chase County taking third with 177.

District Speech

March 11 was the C2-6 District Contest held at PCHS and attended by eight schools including Bayard, Dundy County-Stratton, Hemingford, Maxwell, St. Pat's, Morrill and Sutherland.

District competition consists of one round of preliminary competition (divided into two sections) with the top three contestants from each round advancing to a finals round with two judges.

The top three finishers in each event advance to state competition.

Rachel Patrick, and Sammy Snogren—second; Quinton Hite, Zak Kurkowski, Blake Poppe, Christian White, Colton White—third.

PCHS finished with 136 points, second place went to Maxwell with 94 points, and St. Pat's took home third place honors with 87 points.
